Viktor Blåsjö is an Assistant Professor at the Mathematical Institute of Utrecht University. He is a historian of mathematics with a special interest in the interplay between technical mathematical content and foundational issues in the early modern period. His dissertation formed the basis for his monograph *Transcendental Curves in the Leibnizian Calculus* (Amsterdam, 2017). He also works on issues in the history and philosophy of science and historiography, emphasising the mathematician's point of view.

Giorgio Caravale, Ph.D. 2000, is Professor of Early Modern History at the University of Roma Tre. He is co-editor of the *Catholic Christendom 1300-1700* series published by Brill. He has been a Member in the School of Historical Studies at the Institute for Advanced Study, Princeton (2013-2014), Lauro De Bosis Lecturer in the History of the Italian Civilization at Harvard University (2010-2011), Fellow at the Italian Academy for Advanced Study, Columbia University (2009-2010), Lila Wallace-Reader's Digest Fellow at Villa I Tatti, Harvard Center for Renaissance Studies, Florence (2006-2007). He is the author of *Forbidden Prayer. Church Censorship and Devotional Literature in Renaissance Italy* (Farnham, 2011); *George L. Mosse's Italy. Interpretation, Reception, and Intellectual Heritage* (ed. with L. Benadusi, New York, 2014,); *The Italian Reformation outside Italy. Francesco Pucci's Heresy in Sixteenth-Century Europe* (Leiden, 2015); *Preaching and Inquisition in Renaissance Italy. Words on Trial* (Leiden, 2016); *Beyond the Inquisition. Jean-Pierre Cavallé is senior lecturer in history, philosophy and anthropology at the EHESS in Paris and Toulouse, focusing on moral and religious issues. He is the author, among others, of *Les Déniaisés - Irréligion et libertinage au début de l'époque moderne* (Paris, 2014); *Postures libertines. La Culture des esprits forts* (Toulouse, 2011) and *Dis/simulations. Jules-César Vanini, François La Mothe Le Vayer, Gabriel Naudé, Louis Machon et Torquato Accetto, Religion, morale et politique au XVII^e siècle* (Paris, 2002).

Paolo Cherchi (Laurea in Lettere, 1962 Cagliari, and PhD, Berkeley 1965), is a Professor Emeritus at the University of Chicago where he taught Italian Literature and Romance Philology from the 1965 to 2003; afterwards he taught Italian Literature at the University of Ferrara (2003-2009). His main interests are in Medieval and Renaissance literatures. Among his works are: *Andreas and the Ambiguity of Courtly Love* (Toronto, 1994); *Polimatia di riuso - Mezzo secolo di plagio: 1539-1589* (Rome, 1998); *L'onestade e l'onesto raccontare di Boccaccio* (Fiesole, 2004); *Verso la chiusura. Saggio sul Canzoniere di Petrarca* (Bologna, 2008); *Il tramonto dell'onestade* (Rome, 2016); *Ignoranza ed erudizione. L'Italia dei dogmi di fronte all'Europa scettica e critica (1500-1750)* (Padua 2020). He has edited T. Garzoni, *Opere* (Ravenna, 1994) and *La Piazza universale di tutte le professioni del mondo* (Turin, 1996). Has written over 500 essays mostly on Italian and Spanish literature. He is a "socio straniero" of the Accademia dei Lincei.

Marco Faini is Assistant Professor of Italian at the University at Buffalo (SUNY). Previously he was Visiting Professor at the University of Bucharest, Marie Skłodowska Curie Global Fellow at the Universities of Venice and Toronto, and Research Associate at the University of Cambridge. He has held fellowship at Villa I Tatti. The Harvard University Center for Italian Renaissance Studies and at the Herzog August Bibliothek, Wolfenbüttel. He is the co-editor of *Domestic Devotions in Early Modern Italy* (with Maya Corry and Alessia Meneghin, Leiden-Boston 2019); *Domestic Devotions in the Early Modern World* (with Alessia Meneghin, Leiden-Boston 2019); *A Companion to Pietro Aretino* (with Paola Ugolini, Leiden-Boston 2021) and of *Le doute dans l'Europe moderne* (with Élise Boillet, Turnhout 2022). He is the author of *Standing at the Crossroads. Stories of Doubt in Renaissance Italy* (Cambridge, 2023).

Vera Keller is a Professor of History at the University of Oregon. She is particularly interested in the intersections of policy and science in the history of knowledge in early modern Europe. She is the author of *Knowledge and the Public Interest, 1575-1725* (Cambridge, 2015) and *The Interlopers: Early Stuart Projects and the Undisciplining of Knowledge* (Baltimore, 2023). She has co-edited *Archival Afterlives: Life, Death and Knowledge Making in Early Modern British Scientific and Medical Archives* (Leiden-Boston, 2018) and *Collective Wisdom: Collecting in the Early Modern Academy* (Turnhout, 2022) and published over thirty articles and book chapters. She co-edits the De Gruyter book series, *Cultures and Practices of Knowledge in History*.

Martin Mulso is professor of intellectual history at the University of Erfurt and director of the Gotha Research Center. He studied philosophy in Tübingen, Berlin and Munich; from 2005-2008 he was professor of history at Rutgers University, USA. He is member of several German academies and was member of the Institute for Advanced Study in Princeton (2002/3), the Wissenschaftskolleg in Berlin (2012/13) and the NIAS in Amsterdam (2017). His work on Renaissance philosophy, the history of early modern scholarship and the radical enlightenment received many prizes, among them the prize of the Berlin-Brandenburg Academy of Sciences (2012) and the Anna-Krüger-Prize (2014). Among his publications are: *Moderne aus dem Untergrund. Radikale Frühaufklärung in Deutschland 1680-1720* (Hamburg 2002, English translation: *Enlightenment Underground*, 2015); *Die unanständige Gelehrtenrepublik. Wissen, Libertinage und Kommunikation in der Frühen Neuzeit* (Stuttgart 2007, English translation forthcoming); *Prekäres Wissen. Eine andere Ideengeschichte der Frühen Neuzeit* (Berlin 2012, English Translation: *Knowledge Lost: A New View of Early Modern Intellectual History*, 2022).

Marco Sgarbi is professor of history of philosophy at Ca' Foscari University of Venice. He was the PI of the ERC Starting Grant 2013 on "Aristotle in the Italian Vernacular: Rethinking Renaissance and Early-Modern Intellectual History (c. 1400–c. 1650)". He has been Alexander von Humboldt experienced research fellow at the Max-Planck-Institut für Wissenschaftsgeschichte in 2021-2022; Jean-François Malle-Harvard I Tatti Fellow at Villa I Tatti, The Harvard University Center for Italian Renaissance Studies; Frances A. Yates Short-Term fellow at the Warburg Institute. He is the editor of *Philosophical Readings*, a four-monthly on-line journal, of the *Encyclopedia of Renaissance Philosophy* (Dordrecht, 2023) and of the Bloomsbury Studies in the Aristotelian Tradition. Among his recent publications *The Age of Epistemology. Aristotelian Logic in Early Modern Philosophy 1500–1700* (London, 2023); *The Democratization of Knowledge in Renaissance Italy. The Philosopher and the People* (Amsterdam, 2023).
